

# Recommended After-Care Program for ClearShield®-protected Shower Glass (ClearShield Eco-Glass®)

## Your ClearShield Eco-Glass® Warranty

Registering your new shower glass protected with ClearShield® with us will increase your warranty to a Limited Lifetime warranty for residential showers (see *Warranty for details*).

*\*The durability of ClearShield Eco-Glass® may be affected by the frequency of use of the shower, hardness of the water and the type of cleaning compounds and methods used, all of which are beyond the control of the manufacturer.*

## Recommended After-Care Program

### a) Daily

Rinse off soap and water deposits as necessary with a squeegee. **Important: If you have a water softener, it is critical that you squeegee and/or wipe down until glass is completely dry after each shower** as the softener is adding salt to your water which can cause damage over time.

### b) Bi-weekly (or more frequently dependent upon hardness of water and usage of shower)

Clean glass panels using our ClearShield® After-Care for Shower Glass, which is specially formulated to efficiently clean your shower while enhancing the benefits provided by the special protection. Spray evenly onto the surface of the glass and polish off with a damp cloth or agitate and rinse with fresh water.

We strongly recommend the use of ClearShield® After-Care for Shower Glass for routine cleaning, a specialist and non-alkaline, non-abrasive, water-based cleaner, available from [www.clearshieldonline.com](http://www.clearshieldonline.com). Most common household cleaning products may be used, provided they are not abrasive or high in alkalinity. Alternatively, a simple mix of 5 parts water and 1 part vinegar can be used to clean ClearShield Eco-Glass®.

The following is a list of approved common household cleaners that can be used on ClearShield Eco-Glass®:

- Arm and Hammer Clean Shower Daily Fresh Clean Scent
- Clorox Green Works Natural Bathroom Cleaner
- CLR Fresh Scent Bath and Kitchen Daily Multi-Surface Cleaner
- Lysol Bathroom Cleaner 4 in 1
- Scrubbing Bubbles Natures Source Bathroom Cleaner
- Tilex Fresh Shower Daily Shower Cleaner
- Any cleaner labelled as “Natural”, “Eco-Friendly”, or “Environmentally Friendly”, for example, products listed on the EPA ‘Safer Choice’ list of products (these types of products generally do not contain anything harsh or abrasive)

**Note: ‘Leave-on’ cleaning products are generally not recommended to clean ClearShield Eco-Glass®.**

For heavy limescale, we recommend you use our Limescale Remover product (available from [www.clearshieldonline.com](http://www.clearshieldonline.com)). Allow Limescale Remover to dwell on the surface for 10-15 minutes before scrubbing with an approved non-abrasive pad and rinsing off. Repeat as necessary.

**Use of the following will void your ClearShield Eco-Glass® Warranty:**

- Abrasive cleaning methods or products, such as the use of sharp instruments or abrasive scouring powders or pads
- Cleaning products containing hydrofluoric acid
